## **Quarterly Report of Sanitary Sewer Overflows (SSOs)**

#### 1.0 Purpose

On April 9, 2014, Miami-Dade County entered into a Consent Decree (CD) with the United States of America, the State of Florida Department of Environmental Protection, and the State of Florida. The Consent Decree was lodged on June 6, 2013, and became effective on December 6, 2013. This document satisfies the requirements of Section IX, Paragraph 32 requirement for submittal of the 2014 Quarterly Report No. 4 on or before February 2, 2015.

#### 2.0 Requirements

Section IX, Paragraph 32 of the CD states: "Beginning one (1) month after the first Calendar Quarter following the Effective Date of this Consent Decree, and one (1) month after each Calendar Quarter thereafter until termination of the Consent Decree, Miami-Dade shall submit to EPA and FDEP for review and comment a Quarterly Report. Such Quarterly Report shall include the date, time, location, source, estimated duration, estimated volume, receiving water (if any) and cause of all SSOs occurring in the previous Calendar Quarter." Section IV, Paragraph 8(ii) of the CD defines an SSO as any discharge of wastewater to waters of the United States or the State from Miami-Dade's Wastewater Collection and Transmission System (WCTS) through a point source not permitted in any NPDES permit, as well as any overflow, spill, or release of wastewater to public or private property from the WCTS that may not have reached waters of the United States or the State, including all Building Backups – wastewater backups or releases caused by blockages, flow conditions or other malfunctions of a Private Lateral are not considered as Building Backups."

### 3.0 Sanitary Sewer Overflow Events

This quarterly report also contains information on how the SSO was resolved, including the immediate fix and any proposed long term solution. While not required by the Consent Decree, EPA has requested that the County provide this additional information to aid them in preparing the United States' Semi-Annual Report to the District Court.

#### 3.1 SSOs (Excluding Building Backups)

Table 1 documents all SSO events (excluding Building Backups) for the fourth calendar quarter of 2014. There were a total of twenty six (26) SSO events:

- Seven (7) events involved force mains
- Fifteen (15) events involved gravity mains
- Two (2) events involved pump stations
- Two (2) events involved automatic air release valves

Only one (1) of the SSOs discharged to waters of the United States.

The following addresses acronyms and abbreviations used in the table.

FM Force Main PS Pump Station

GM Gravity Main ARV Manual Air Release Valve
LAT Lateral AARV Automatic Air Release Valve

#### 3.2 Building Backups

The County follows standard procedures to resolve and minimize the occurrence of Building Backups. These procedures will be re-evaluated in the development of the new CMOM Programs required by the current Consent Decree.

Presently, the Department's procedures for the response to, and the reporting and documenting of Building Backups are different from those of sanitary sewer overflows within the Department's waste collection and transmission system. Additionally, the "Time" and "Duration" parameters are seldom characteristically the same between the two types of SSO events. For these reasons, Building Backups have been included in a separate table and the "N/A" designation has been used for some "Time" and "Duration" entries. The Building Backup information can be viewed in Table 2.
