On June 2, 2021, Miami-Dade County (County) received written notification from the Florida Department of Environmental Protection (FDEP) for funding under OGC Case No. 03-1376(A) to resume on July 1, 2021. Pursuant to the Consent Decree, Miami-Dade shall provide funding to FDEP to monitor the County's compliance with the terms of this Consent Decree at the rate of \$55,000 per year until this Consent Decree is terminated.

In accordance with the provisions of the above-referenced Consent Decree, on behalf of the County, WASD submits Check No. 00750273, payable to "State of Florida Department of Environmental Protection" as payment for a rate of \$55,000 as indicated.
