Payment of 2023 – 2024 FDEP Demand for SSO Stipulated Penalties**

Dear Sir or Madam:

Miami-Dade County (County) received a Demand for Stipulated Penalties letter from the Florida Department of Environmental Protection (FDEP) dated October 10, 2025. Based on the Quarterly Reports submitted to United States Environmental Protection Agency (EPA) and FDEP pursuant Section IX, Paragraph 32 of the Consent Decree (CD) for the reporting period of July 1, 2023 and December 31, 2024. FDEP elected to assess stipulated penalties for twenty-two (22) Sanitary Sewer Overflows (SSOs) of 1,000 gallons or more that did not reach waters of the United States. FDEP assessed stipulated penalties pursuant to Section X, Subparagraphs 42.(a)(i) through (v) and the Order Modifying Section X (Document 156) of the CD in the amount of \$30,500.


As required, the County disbursed a \$30,500 Check to the FDEP and was sent via certified mail. Please find a copy of the check to FDEP attached herein.

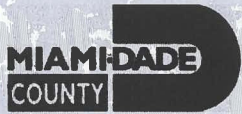
